Sullivan assured those who spoke about these issues that the Board would revisit this issue by adding this as an agenda item at a future meeting.</p>

FOR YOUR INFORMATION	Commr. Campione reported that the Lake-Sumter MPO (Metropolitan Planning Organization) had their Executive Committee Meeting, and there would be a brief discussion at the next MPO meeting about how they would plan and coordinate for intersections and signalization in the future after a storm of the magnitude of Hurricane Irma. APPROVED	Commr. Sullivan relayed a request from Sheriff Peyton Grinnell for emergency funding from the County's Fiscal Year 2016-17 budget in the amount of \$500,000 to fund his expenses related to Hurricane Irma per Florida Statute 30.49. <b>The Board approved declaring this request as an emergency item, as well as the \$500,000 funding request from the FY 2016-17 General Fund reserves and authorized the Chairman to send a letter to the Sheriff requesting that he identify \$500,000 in efficiencies and corresponding reductions in his FY 2017-18 budget and notifying him that the County would be reducing his FY 2017-18 budget by that amount, which is .85 percent of the total budget.</b>	SULLIVAN
APPROVED	Commr. Sullivan asked that County staff explore funding options for mosquito control as an emergency request under Public Health, Safety, and Welfare due to flooding conditions brought on by Hurricane Irma and also to authorize the County Manager to supplement what the County normally spends on those efforts for up to an additional \$50,000 for mosquito control, as well as for the Chairman to authorize an additional \$50,000 if it	SULLIVAN

	was still needed for those efforts. <b>The Board approved that request as well as declaring this as an emergency item.</b>	
CONSENSUS	Commr. Sullivan asked for consensus to grant the Sheriff's request for \$196,140 in order to make improvements to the detention center and to send a letter to the Sheriff requesting that it be taken out of the \$1.2 million allocated to the Sheriff for capital expenditures from the sales tax for calendar year 2018.
